### **Asking Better Questions**

In our contemporary world, the loudest voices like to tell us how to think, feel, be or do. The loudest voices like to paint a picture about a situation that, from their perspective leads only to black or white answers. Yet, as people of faith, we know that sometimes an answer can be black or white, and sometimes it can also be gray. Let's look at two different examples within the Bible, one gray and one black or white. Yes, the two examples are not similar, but over time, both positions were defended by using the words of the Bible.

What do I mean by this? Let's look at the first example. There are multiple passages from the Old and New Testaments that share how we are to treat slaves. Societally it was a known fact of Ancient Times that conquered people, generally the men of the society, would be enslaved. Especially if that particular kingdom was rebelling against a much larger empire. Biblically there are more passages that deal with proper treatment of owned slaves than passages that are opposed to the use of slavery in general. Since more Biblical passages accepted slavery, many people who would have called their selves faithful Christians defended the use of slavery. Though the way that those folks used the Biblical sources, in this instance, were not twisted out of a larger narrative context, the institution of slavery is counter to the message of love found in the Gospel of Jesus Christ.

As Christians it is easy for us to fall back on the words, "Well, it's in the Bible, it must be [insert words...]." Sadly, some of those times have led to entire groups of people being disregarded or unworthy of God's love. To be sure, there are times where falling back on those words are wholly appropriate. For example, Jesus himself declares to the Disciples in the Last Supper, "This is my body...this is my blood." Jesus doesn't say that the bread represents his body. Or that the bread is symbolically his body. Jesus clearly states that the bread is his body. Therefore, we as Lutherans confess that Holy Communion is the true body and blood of Jesus Christ in the form of bread and wine.

This leads us back to the "asking better questions" idea. What differentiates the example about slavery and the example of Holy Communion is extremely important. Slavery is an example of sin alive and present in the world because one person believes they are able to possess and/or buy another person. An example that shows how human beings are susceptible to fall under the influence of power, wealth, money, land, status, etc. It is counter to the love Jesus proclaims. It is counter to the way in which Jesus calls us to interact with our neighbor. Truthfully, we don't even need a Biblical source to tell us slavery is wrong. We feel that in our being.

Therefore, I would argue that slavery is viewed as gray. Not gray in that its practice is acceptable. This time gray because slavery is found in the Bible. In some places, the practice of it is defended in the Bible. But Jesus came to make people equal. To call us to love everyone. Thus, by asking better questions we can conclude that God does not want human society to interact in a way where some people subjugate other people for their gain.

On the other hand, Holy Communion offers us a tangible experience of the grace of a God who forgives us of our sins and offers us eternal life. In the reception of Communion, everyone is placed on equal ground. No one person is higher or better than another because all have sinned and fallen short of the glory of God. It is a perfect embodiment of the love Jesus proclaims. Jesus' words allow us to interpret Communion as black or white.

Now as we try to ask better questions, we may fall into the temptation of asking questions to support our own ideas. It is an easy trap to fall into and not realize that you are there. What I am trying to say is that if a passage is difficult to understand, Luther would tell us to find another passage in Scripture that is more clear that sheds more light on the larger narrative of the Bible which helps make an unclear passage more clear.

Notice how in the example of slavery, I used God's love in Christ Jesus sent to save us from our sins as the Biblical reason to say that slavery, while in the Bible, is not a practice supported by God. If a person truly loved another person, they would be abhorred at the idea that they could own another person. Because owning someone does not exemplify God's love. Similarly, God's love in Christ Jesus is also one of the reasons that Communion is interpreted and defended as Jesus' body and blood. The other being that Jesus himself states what Communion becomes when using the Words of Institution.

All of this to say, God wants us to learn about our faith within the words of Holy Scripture. God wants us to ingest them and remember them. God wants us to hear the larger narrative of the Biblical story and how the Father's Only Son, Jesus Christ, changes everything. However, God doesn't want us to use the words of the Bible at the expense of other people or to tear them down.

Finally, brothers and sisters, remember the words of John 3:16-17. "For God so loved the world that the Father gave his only Son, so that everyone who believes in the Son may not perish but may have eternal life. Indeed, God did not send the Son into the world to condemn the world but in order that the world might be saved through the Son." God gifts us the holy and sacred words of Scripture so that we may build one another up in faith until the day that we all gather around the heavenly throne of God.
